### News to Know

#### • Notification Process Change

CAPTE has modified the notification process to make use of the CAPTE portal. Programs use the portal to submit notifications to CAPTE. **Do not send notifications via email.** Program directors and program administrations should find the notification link on your home page when you log into the CAPTE portal. Refer to the <u>notification video</u> for guidance on how to submit a notification. Locate the link to the posted CAPTE Notification Training video on the <u>CAPTE Accreditation Resource</u> page.

#### New CAPTE Program Review Process Begins

CAPTE is implementing a new accreditation review process that was piloted in 2022 and 2023. Programs under review for initial or reaffirmation accreditation will have a scheduled on-site visit date as in the past. Self-study reports will be due 75 days prior to the beginning of the scheduled on-site visit. Accreditation staff provide an alternate on-site visit date to be used if staff determine from a document review that the original Self-Study Report submitted needs to be returned to the program for revision and resubmission. If the Self-Study Report is returned to the program, the original scheduled on-site visit date is cancelled, and the alternate on-site visit date will be the date of the visit.

The new process involves a four-person team. Two reviewers complete a document review and submit their draft report. Two reviewers complete the on-site visit once the Self-study Report is approved to move to the on-site visit phase.

The new process will be as follows:

- 1. On-site visit date determined.
- 2. SSR submitted 75 days prior to beginning of the scheduled on-site visit.
- 3. Accreditation staff completes check-in to confirm all required documents are submitted.

- 4. Two CAPTE reviewers complete document review.
- 5. Staff review document review report and determine if the on-site visit can occur as scheduled or if the SSR will be returned to program for revisions and resubmission.
- 6. Program receives a copy of the document review report whether on-site visit occurs as scheduled or if SSR is returned for revisions and resubmission.
- 7. If SSR requires revision and resubmission, program will have 30 days from receipt of document review report to complete revisions and resubmit SSR.
- 8. If SSR revisions are required, the on-site visit will occur during the alternate on-site visit date.
