CAPTE is a specialized accrediting agency that accredits physical therapy educational programs across the United States. The information presented below is in accord with CAPTE's disclosure policy; staff of the Commission cannot comment further on questions specifically related to the physical therapist **assistant** education program at **Concorde Career College – Memphis**.

On «End_Date_CAPTE_Meeting_CAPTE_Meeting», the Commission on Accreditation in Physical Therapy Education made the following decision regarding the physical therapist **assistant** education program at **Concorde Career College – Memphis**:

ACCREDITATION WITHDRAWN

What is the program's Accreditation Status?

Accreditation Withdrawn

CAPTE will act to withdraw Accreditation when a program's accreditation status is Probationary Accreditation and it has failed to show evidence of substantial compliance with any one or more of the Standards and Required Elements within two (2) years of being determined to be out of compliance or, if the program has been granted an extension of probation for good cause and the program has failed to demonstrate compliance within the maximum two year extension period.

Why was accreditation withdrawn?

[if applicable] The program was originally placed on Probation on XXX because of its inability to demonstrate compliance with the Standards and Required Elements. The program was judged to be out of compliance with the following required elements: **1C2**.

In sum, the program has remained out of compliance since XXX with XXX requirements such that there is reason to question the institution's ability to offer the educational experiences and outcomes to meet CAPTE standards.

What options does the program have to respond?

When accreditation is withdrawn by the Commission, programs have the right to reconsideration of the decision and another level of appeal available to accredited programs. The program was notified about its due process options in the Summary of Action and the timelines associated with each option. Failure to request reconsideration is interpreted as the institution accepting the decision and its finality on [calculate using info below and delete paragraph]. Once the action is final, it is not subject to further reconsideration or appeal.

[An action to withdraw accreditation shall become effective forty-five (45) days following the date of the CAPTE action, or thirty (30) days after the date on which the official notification on the action is received by the institution, whichever is later, unless the institution seeks reconsideration of the action, in which case the accreditation status decision shall not become effective until the date upon which a final decision is rendered on reconsideration or appeal.]
